PRESIDENT'S MESSAGE

CONFERENCE-CALL PLANNING

Your state leaders have been phone conferencing with our State Organizer, Katherine Yelle, to plan approaches for new initiatives. Planned public policy and Tennessee legislative events are being held in February and March by the Maryville Branch with invitations to the Knoxville and Oak Ridge Branches and in Nashville with the Murfreesboro Branch assisting. UT-Chattanooga has received for the second year the Elect Her Award. A re-established branch in Chattanooga may be a possibility in the near future. Taylor Emery and Anne Loy are busy signing up new college/ university partners. Ruth Smiley and Charlotte Crawford have almost reached their goal of selling an adequate number of their book, Tennessee Women of Vision and Courage, to enable them to place the book in every Tennessee high school library. 

Equal Pay Day is Almost Here

Equal Pay Day is coming up on Tuesday, April 8. AAUW describes it as "the symbolic day when women's earnings finally catch up to men's earnings from the previous year. Due to the gender pay gap, it takes women an extra three months of wages to make up that 23% difference."

Branches are planning activities to mark this day. How about having your local city council or county commission issue an Equal Pay Day Proclamation? How about preparing letters to the editor as private citizens and submitting them to your local newspapers?

This is the Equal Pay Act's 50th Anniversary. We need a Paycheck Fairness Act birthday. The AAUW web site has many resources to help you plan meaningful activities.

Pay Equity in Tennessee December 2013

Despite civil rights laws and advancements in women's economic status, workplace discrimination persists. The wage gap is found across all racial and ethnic groups and in every state. On average in Tennessee, women working full-time earn **77 cents for every dollar** a full-time male worker earns. In some areas, earnings dropped as low as **72** cents for every dollar a full-time male worker earns.¹

The Gender Pay Gap has Real Consequences for the Local Economy

- Forty percent of households with children include a mother who is the sole or primary earner for her family.² Thus, pay equity is not just a matter of fairness, but the key to families making ends meet.
- Women also play a key role in making purchasing decisions for their households, so when women's paychecks suffer due to wage discrimination, the local economy suffers. In a 2011 survey, nearly 75 percent of women described themselves as the primary shoppers for their households, and it is estimated that women "control \$12 trillion of the overall \$18.4 trillion in global consumer spending."
- At a time when the economy is still struggling, the gender pay gap could be dragging the recovery even more.

Existing Federal Legislation is Not Enough

Congress enacted the Equal Pay Act in 1963, but the persistence of wage discrimination 50 years later is attributable in part to the Equal Pay Act's limited scope.

- Not only does it fail to cover wage discrimination based on race (although Title VII of the 1964 Civil Rights Act does), it also fails to provide equal pay for jobs that are comparable but not identical.
- Further, it excludes part-time or contingent workers, does not allow groups of workers to file class-action suits, and lacks protections for employees who ask about employers' wage practices or share their salary information.

The U.S. Supreme Court set us back even further in May 2007 when it issued a decision in *Ledbetter v. Goodyear* that severely limited the ability of victims of pay discrimination to seek remedies under Title VII.

- Fortunately the 110th Congress quickly introduced legislation to correct the Supreme Court's misstep, and this legislation became law on January 29, 2009.
- The Lilly Ledbetter Fair Pay Act restored the long-standing interpretation of federal laws and policies that allow
 employees to challenge any discriminatory paycheck they receive but we're still back at square one, with the
 outdated Equal Pay Act of 1963.

Closing the Gap: Action Needed in Tennessee

A combination of state and federal action is needed to enable women to bring home the pay they have rightfully earned. With the current gridlock at the federal level, it is even more important for Tennessee lawmakers to act **now**.

- Pass anti-retaliation laws: Right now, employers can retaliate or even fire! employees who ask about or share wage information. Tennessee should fix this by passing an updated equal pay law that bans retaliation.
- Pass local pay equity laws: Albuquerque, NM, recently passed legislation encouraging equal wages for equal work by giving a bidding advantage to contractors who promote equal pay in their companies. This law can also be passed at the state level to affect all contractors in the state, instead of only those in a particular city.

On Monday, March 31 an event in Lawson Auditorium, Fayerweather Hall on Campus will be held to explain to the students the effect of unequal pay.
